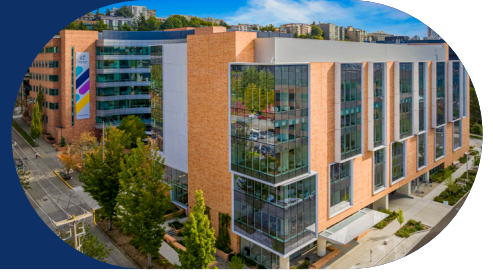


# Directions

## South Lake Union Clinic

### How do I find the right clinic building?

The two clinic buildings are connected but have separate parking structures and addresses. If using a mobile map app or a rideshare service, we recommend using the exact address above for the building where your clinic is located. Parking in either garage will allow you to get to your clinic, but the corresponding garage or drop off area will be more convenient. The two buildings are connected by a corridor on the first floor. If you enter Building 2 from the parking garage, you will be on Floor A. Take the elevator up to Floor 1 and follow the signs to enter Building 1.

# Driving directions

## From I-5

- Take exit 167 for Mercer St./Seattle Center.
  - If you are northbound on I-5, you will exit I-5 from the far left lane.
  - If you are southbound, you will exit I-5 from the far right lane.
- As you exit, move to the far right lane.
- Turn right at the end of the ramp onto Fairview Ave. N.
- Veer right at the light, staying on Fairview Ave. N. Travel one block to Aloha St.
- Turn right onto Aloha St., and after 0.1 mile, turn right to arrive at the clinic.
- To enter the Building 1 parking garage, turn right into the alley after Yale Ave. N., just before the clinic circle driveway. Then, turn left into the parking garage. (If you have reached Eastlake Ave. E., you have driven too far.)
- To enter the Building 2 parking garage, turn right onto Yale Ave. N. Then, turn left into the parking garage.

## From the east via 520

- Exit onto I-5 south.
- Follow the directions above from I-5.

## From the east via I-90

- Take I-90 west.
- Exit onto I-5 north.
- Follow the directions above from I-5.

# Parking information

**Patients and their visitors may park in either of the South Lake Union clinics' underground parking garages.**

## Building 1 parking

- The parking fee for Building 1 is \$1 an hour, up to a maximum of \$4.
- Parking in the Building 1 garage is free on weekends and holidays.

## Building 2 parking

- The parking fee is a flat \$4 fee for Building 2.
- Valet parking is required in Building 2, which has an automated parking structure that uses a mechanical system to stack vehicles vertically to limit space. This means that no people or animals will be able to remain inside your car if you're using the Building 2 garage.
- Parking is not available in Building 2 on weekends and holidays.

## Other considerations:

- There is limited paid street parking.
- Please allow extra time to get to your appointment to allow for any construction and traffic delays.
- There is one EV charging station in the Building 1 parking garage, located immediately inside the entrance. EV charging is not available in the Building 2 parking garage.

## Valet

Free valet service is available for paid parking in both garages at Fred Hutch: Valet service is optional in the Building 1 garage; the Building 2 garage is valet-only. If you prefer to park your own car, park in the Building 1 garage.

Valet service is available only on weekdays, from 7 a.m.–6 p.m. for Building 1 or 6 a.m.–6 p.m. for Building 2. Keys not picked up by 6 p.m. will be at the security desk on the main floor of Building 1, which is open 24 hours. Please do not tip, as our policy doesn't allow our workforce to accept cash or gifts regardless of value.
